PARENTS CHOOSE THE SCHOOL BECAUSE IT OFFERS QUALITY EDUCATION, INCLUDING ENGLISH PROFICIENCY CLASSES, A BIBLICAL WORLD VIEW, A SAFE AND FRIENDLY ENVIRONMENT, AND A CURRICULUM FOCUSED ON DEVELOPING CRITICAL THINKING AND PROBLEM SOLVING.
